Our Mountain Empire Chapter of MOAA has had an eventful year. We were able to present five scholarships and awards to ROTC and JROTC cadets. We have planned to present more in 2026. We received a Five Star Level of Excellence award earlier this year, and Five Star Harris Communications Awards for both our newsletter and website. The Tennessee Council of Chapters received a President's Award from MOAA for 2025, no doubt partially due to the hard work we did in revitalizing the East Tennessee Chapter in Knoxville. By the way, the East Tennessee Chapter has renamed themselves the Smoky Mountains Chapter, so don't be confused if you see that name.

We are in the final stretch of getting liability insurance for MECMOAA. This will allow us to receive grant funds from MOAA and from local businesses to provide direct financial assistance to needy veterans in our region and to fund

projects that will benefit these veterans. We owe Steve Pecinovsky our gratitude for his diligent work in analyzing and sourcing the right policy at the right price for our needs.

Our JROTC outreach led to snagging Kevin Selhorst, the JROTC guy at David Crockett High School (Thanks, Ed Champion!) as a MECMOAA member and new Board member. Kevin will work with Ed to improve our outreach to all of the JROTC programs in our region, and to work with the JROTC programs and guidance counselors at many high schools to improve the information provided to high school students early in their four years and increase their readiness and competitiveness for ROTC and Service Academy appointment. Dan Bishop, Brett Monette, Jim Paffenroth, and Mark Tipton represented our Chapter by comprising the entire Academy nomination board for U.S. Senator Blackburn in Johnson City this November, and they joined statewide representatives in Nashville earlier this month to pick Senator Blackburn's final nominees across the state. In 2026, we'll take the initiative to help local high school students best prepare for nomination and appointment selections as early as possible, increasing their chances of securing these amazing opportunities to serve.

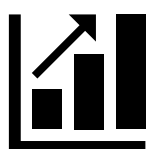

## Legislative Update

### Final update on topics presented at 2025 Chapter Meetings:

- 1. CAUTION:** Budget risk to DOW & VA persist, and the past shutdown and CR that expires on Jan 30, 2026 elevates the risks.

URGENT ACTION: MECMOAA members should register under the Legislative Action Center (LAC) and actively engage congressional reps. As of October 2025, engagement resulted in 20K messages to 500 congressional members.

The FY26 NDAA was signed by the President on 18 December; final 2026 COLA for retiree/VA disability pay is 2.8%, while active-duty, Guard, and Reserve basic pay increases 3.8%.

### 2. MOAA's 119<sup>th</sup> Congress Legislative Priorities

Currently Serving: urge lawmakers to 1) improve housing oversight to address health, safety, accountability, detailed financial reporting, improved tenant protections, medical care for illnesses caused by poor housing conditions; 2) restore 100% BAH; 3) resume consumer financial protection bureau in examinations for military lending act issues

Retirees/veterans: end wait period for toxic-exposed veterans; more perfect PACT ACT, support the Richard Star Act to authorize combat-injured vets to receive full DoD retirement pay and their full VA disability compensation

*Family/Survivors:* urge lawmakers to support: Love Lives On to protect the right to remarry and retain benefits, parity for surviving spouses by aligning dependency and indemnity compensation with other federal survivor benefits, support the Fairness for Servicemembers and their families Act to require VA to review and update life insurance coverage, support the Improved and Enhance the work opportunity tax credit act

*DoD Health Care:* urge legislators to improve prenatal care under TRICARE, expand TRICARE eligibility for Guard & Reserve, improve OB-GYN access for military families, fix the TRICARE young adult coverage gap, protect GLP-1 weight-loss meds for retirees covered by TFL.

*VA Health Care:* improve veterans home care-giving and long-term care: S.879, The Veteran Caregiver Reeducation, Reemployment, and Retirement Act, (3R Act) reintroduced on 6 Mar; support 14.3M mil & vet caregivers, 74% caring for vets > 60 years old; May hearing supported the 3R Act. Legacy caregivers safe until 2028 based on new rule published Sep 29.

*Persistent Efforts:* Fair COLA, Arlington National Cemetery access, pay increases, TRICARE or pharmacy fee increases that exceed military/retiree pay, stop unequal decrements to compensation and benefits based on rank, age, family composition, retirement status, or disability benefits.

***3. U.S. Senator Blackburn has agreed to speak at a future MECMOAA mtg, but not scheduled yet; hoping for a spring 2026 visit***

As the status of current legislation can change quickly, we must individually be “tuned in” to what’s happening real-time regarding programs and initiatives that we care about. We must also act in a timely manner to engage our elected representatives so we don’t miss our best opportunities. You can do that easily through **MOAA’s Legislative Action Center**.
